



Qualifier Legend

- **B1** The target analyte detected in the calibration is at or above the limit of quantitation, but the sample result for potency testing, is below the limit of quantitation.
- The target analyte detected in the calibration blank, or the method blank is at or above the limit of auantitation, but the sample result when testing for pesticides. **B2** fungicides, herbicides, growth regulators, heavy metals, or residual solvents, is below the maximum allowable concentration for the analyte.
- **D1** The limit of quantitation and the sample results were adjusted to reflect sample dilution.
- 11 The relative intensity of a characteristic ion in a sample analyte exceeded the acceptance with respect to the reference spectra, indicating interference.
- When testing for pesticides, fungicides, herbicides, growth regulators, heavy metals, or residual solvents, the percent recovery of a laboratory control sample is L1 greater than the acceptance limits, but the sample's target analytes were not detected above the maximum allowable concentrations for the analytes in the sample.
- The recovery from the matrix spike was high, but the recovery from the laboratory control sample was within acceptance criteria. M1
- The recovery from the matrix spike was low, but the recovery from the laboratory control sample was within acceptance criteria. M2
- The recovery from the matrix spike was unusable because the analyte concentration was disproportionate to the spike level, but the recovery from the laboratory **M**3 control sample was within acceptance criteria.
- The analysis of a spiked sample required a dilution such that the spike recovery calculation does not provide useful information, but the recovery from the associated M4 laboratory control sample was within acceptance criteria.
- **M5** The analyte concentration was determined by the method of standard addition, in which the standard is added directly to the aliquots of the analyzed sample.

- Q1 Sample integrity was not maintained.
- 02 The sample is heterogeneous, and sample homogeneity could not be readily achieved using routine laboratory practices.
- Testing result is for informational purposes only and cannot be used to satisfy dispensary testing requirements in R9-17-317.01(A) or labeling requirements in **Q**3 R9-17-317.
- **R1** The relative percent difference for the laboratory control sample and duplicate exceeded the limit, but the recovery was within acceptance criteria.
- **R2** The relative percent difference for a sample and duplicate exceeded the limit.
- The recovery from continuing calibration verification standards exceeded the acceptance limits, but the sample's target analytes were not detected above the **V1** maximum allowable for the analytes in the sample.
